ACQUISITION OF 45% OF THE EQUITY INTEREST IN CHINA SATELLITE MOBILE COMMUNICATIONS GROUP LIMITED BY ARMARDA GROUP LIMITED

The Board refers to the announcements dated 29 March 2011, 29 September 2011, 2 December 2011, 3 January 2012, 28 February 2012, 21 March 2012 and 18 May 2012, 11 July 2012, 23 July 2012, 27 August 2012, 16 September 2012, 26 September 2012, 31 October 2012, 2 November 2012, 16 November 2012, 27 November 2012, 18 December 2012, 26 February 2013, 21 March 2013 and 31 March 2013 (collectively the “**Announcements**”) and the circular dated 5 December 2011 and 31 October 2012 (collectively the “**Circulars**”) relating to the acquisition of 45% (“**Acquisition**”) of the equity interest in China Satellite Mobile Communications Group Limited (“**CSMCG**”) by the Company.

Unless otherwise specified herein or where the context otherwise requires, capitalised terms used in this Announcement shall have the same meaning as used in the Circulars and the Announcements as the case may be.

The Directors understand from the press release made by CSMCG (the wholly owned subsidiary of CSMCG) dated 22 April 2013 that it has on 19 April 2013 entered into a strategic business agreement with the subsidiary of China National Postal and Telecommunications Appliances Corp (“PTAC”), China PTAC E-commerce Technology Co., Ltd. (“PTAC E-commerce”). Under the agreement, CSMCG has appointed PTAC E-commerce as the sole import agent and a key distributor of Thuraya’s mobile satellite products and services in China.

Lasting till 31 December 2018, this agreement will see PTAC E-commerce procure at least 15,000 Thuraya mobile satellite phone sets along with “1349” prepaid cards within the first year of the agreement. Following the signing of the agreement, PTAC E-commerce has placed an initial order of 1,000 Thuraya mobile satellite phone sets together with 1,000 units of “1349” prepaid cards. Notwithstanding, the PTAC E-Commerce’s commitment of 15,000 units for the first year and save for the initial order of 1,000 units, the orders for the remaining 14,000 units have not been confirmed.

Barring from unforeseen circumstances, it is not expected to have any material financial impact to the Group’s EPS and NTA per Share.

The press release by CSMCG on the above matter has been attached for information.
